RIDERSHIP RECORD TOTALLY SHATTERED

On the evening of November 24 the village of Shelburne Falls was lit up like, well, a Christmas tree. It was the annual Moonlight Madness event, with lights and luminaries everywhere and all the shops open late. Snow was missing from the scene this year, but nobody minded, so the entire world as we know it descended on the scene.

Equally well-lit was trolley No. 10. Whenever it arrived at Salmon Falls station it was highly visible to anyone anywhere near the river, and in no time crowds of people were queued up at the makeshift ticket office (a card table with a light over it and no shelter for Betsy), buying tickets and being loaded onto No. 10 for a ride past the colorfully lighted steam engine No. 10 to the Visitor Center and return.

CV caboose No. 4015 had been moved up earlier to the Salmon Falls end of track. It too was brightly strung with lights, and a cheery fire burned in its stove - the only truly warm place on the system. Customers could enjoy cider and cookies while waiting their turn to ride.

At the Visitor Center more passengers got tickets for a round trip in the opposite direction, or bought items at the TrolleyShop. From around 5pm until 8pm there was no letup in crowds coming and crowds going. Salmon Falls continually called for batches of tickets or more cash for making change. It was delightful pandemonium at both ends of the line.

No. 10 ran like a real streetcar, back and forth for hours, stopping at each end only long enough to change ends and customers. There was enough crew so that some could be relieved to eat or thaw out.

It was close to 9pm when the frozen Salmon Falls agent stumbled into the ticket office, groaning under the load of currency she was carrying. Tickets were counted, money was collected, books were cooked, and the night's ticket count was announced.

Until then, the record for a single day had been set in one of the first years at 235 tickets. Rarely in 2006 did we ever approach 100 tickets in a day.

Finally everything was totalled up, and the total was announced: 379 tickets issued! Outstanding!!

PUMPCAR GOES 200 MILES IN UNDER THIRTY HOURS!

Well, sort of. SFTM members Carl Carlson and Kari Winfield, from Gardner, kindly drove to SFTM on September 8, picked up our pumpcar, and hijacked it to Vermont, returning it on the 9th, together with \$127 in cash that they had liberated from innocent bystanders!

Carl's report of this slippery deal follows:

The sky was mostly sunny as people of all ages partook of all-things-railroad at the *Glory Days of the Railroad* Festival at White River Jct, Vermont, On September 9th, 2006. The Central Vermont Railway pumpcar No. 21, located at the Shelburne Falls Trolley Museum (SFTM) in Shelburne Falls MA was in attendance with help from SFTM members Carl Carlson and Kari Winfield. The pumpcar, the oldest operating piece of railroad equipment at the festival, provided a great turn-of-the-century hands-on experience for all. Smiles abounded on the faces of all those who dared to exert the effort to pump the handle of the car for a short ride down the isolated segment of track in the center of the wye trackage. The location worked out well, for, as many visitors boarded the Vermont Rail System excursion train they could see the SFTM display, and upon return, a stream of people lined up to take a ride. Adult visitors were very interested in the history of the car, many saying "I always wanted to do that. I've seen it in the old westerns," while the young were more interested in making the car go as fast as possible! Many attendees gave donations to the museum and took the new informational SFTM rack card available on the SFTM display board.

Complementing the pumpcar at the festival was its successor in the historical progression of railroad track inspection—a motorized track car. A Fairmont MT19 of Canadian National Railway heritage, brought by the Cotton Valley Rail Trail Club, provided rides to festival attendees on an adjacent track. Static displays of New England Central, Claremont Concord, and Vermont Rail System diesel locomotives and Rutland passenger cars, as well as vendors of model trains and railroad-related items were present. A great day was had by all, and a few more people were informed about the Shelburne Falls Trolley Museum—hopefully we'll see some of these new fans soon at SFTM!

Our sincere thanks to Carl and Kari for their efforts and their trailering of the pump car on this epic journey!

There are numerous Byzantine rules regarding eligibility for the award, and one of those was slightly bent. The Directors were unable to pick one candidate because there were two who seemed equally deserving. And so it went. Motormen Jim Wholey and Tom Watson, both ever ready to jump in whenever crews were short, were presented the award. Well done, Jim and Tom!

PHYSICAL PLANT IMPROVEMENTS

Since the last TRANSFER came out there is much progress to report in SFTM's rental space and restroom improvement project

Led by President Sam and VP Dave Dye, the all-purpose duo, work has been essentially completed on the two new accessible restrooms, which are now in service. Hot water comes out of the appropriate faucets, doors lock, ventilation fans and lights come on automatically. Electric heat and lots of insulation make for a very comfortable visit to these rooms, which are by far the most popular sites at the Visitor Center.

On the other side of the new firewall, the space rented by the Children's Art Museum has been completed by contractors. Classes in art and in music are already attracting a toddler clientele. A gas heating system has been installed and large sink put in. Numerous new windows let in lots of daylight. The contractors built an emergency exit on the side nearest the railroad. Its landing has been dubbed the "Pan Am Porch".

The accessible ramp has been finished except for handrails. It has already been tested to her satisfaction by an SFTM member who uses a wheelchair.

A few odds and ends of work need to be done before Sam and Dave can declare victory and go back to working elsewhere at the museum.

These projects, plus the steel roof put on the building a year ago, have left the ex-Agway building in good shape for its immediate needs. Rental income from this building should become a significant part of our revenue stream. Although there was some grant money for all this, SFTM has had to invest heavily here. Because of cost overruns, our capital reserve has been more depleted than we planned it to be, but as an investment in the long term the potential payback looks encouraging. On the other hand it will be necessary to defer any future capital projects (bigger/better museum in freight house, track extensions, that badly-needed fireproof car barn, etc.) until such time as more capital can be found.

We continue to search for grants and other funding. There is a new state program for promoting tourism, but the funding for these has already found its way under Boston harbor, never to be seen again.

We've gotten lucky before - it can happen again.

At left is a schedule of train and postal services, plus the all-important locations of all the village fire-alarm boxes. This was from a small village information booklet put out by W. C. Thompson's Drug Store at 5 Bridge St.

Missing seems to be the NYNH&H train service southward. As is Thompson's Drug Store itself today.

The businesses change through the years, but the buildings seem to live on, mostly unchanged.




